### Ward 3 Councillor Matt Shoemaker -

To keep the campground operating, the taxpayer was being asked to spend more than a quarter-million dollars for infrastructure improvements that services 200 or 300 people. The residents there would say it served much more than that, but even if we included family members and extended family members, the number of people the campground serviced was limited as a percentage of the total population. If we were eager to put \$250,000+ into an initiative, my opinion is that we should put it into an asset that is more accessible to the public, such as the Pointe des Chenes beach. That's why I was keen to see improvements to the park, including the summer beach bus, so that the great asset we have (the only city-owned beach), would be well used and offer patrons something to do.

I would not support re-opening the campground there. I would like to see what it will cost to fix the water problem first, and from there, determine what we should do with it. If it made the most sense for the city to maintain ownership and expand the beach/playground, I would be happy to support that.

### Ward 5 Councillor Corey Gardi -

I want it to remain a campground. I would like the water issues remedied as best as possible by Transport Canada, whom I believe is the entity responsible, due to the issues created originally on the airport property.

Personally, I think it would be best if it were a privately owned and operated campground. I am not in favour of developing it into residential lots.

In the meantime I am looking forward to the additional investments we are making out at the day park including frisbee golf course, volleyball play area and our beach bus that is transporting families out there over the summer.

## Ward 5 Councillor Matt Scott-

It's no secret that I was strongly in favour of keeping the campground open and paying for the necessary repairs to make the water potable. I met with the organizers and supporters of the rally held outside of Canadian Tire prior to the majority decision to close the park (which I voted against, of course) and they were all very passionate about their enjoyment of the campground, often referring to it as a community. I believe that Pointe Des Chenes Campground was a staple for Sault Ste. Marie in that it offered many families from surrounding areas and beyond an opportunity to explore our city and what we have to offer. I have first hand experience of camping there and meeting people from other areas of Ontario, from across Canada, and even International campers. My intent is to support any options we have to reopen the campground.

As for the whole park, we are actively making improvements on it and this summer will be installing volleyball and pickle ball courts. It's important to the residents of Ward 5 to have these amenities as we feel left out of city wide offerings – an example of this would be Ward 5 not having one single city operated ice rink, indoor or outdoor, despite being the largest Ward by area. I will continue to push for and support any initiatives that will benefit the constituents of my Ward and the city of Sault Ste. Marie. Parks are important and I know the west end has a lot of growing families which is why I have been vocal about my support for improving our parks in Ward 5.
